Adotei Akwei is Deputy Director for Advocacy and Government Relations for Amnesty International USA. He rejoined AIUSA in September 2010 after serving as the Senior Policy Advisor and Asia Regional Advocacy Advisor for CARE USA. Before joining CARE, Adotei worked with Amnesty International USA for 11 years, first as the senior Advocacy Director for Africa and then later as Director of Campaigns. He has additionally held positions at Human Rights First, the American Committee on Africa, and the Africa Fund.

Adotei received his Master's degree in International Relations from the College of William and Mary and his Bachelor's degree from the State University of New York College at Purchase. He is a political analyst and an experienced advocate on civil, political, economic and social rights, U.S. foreign and security policy, and a rights-based approach to ending poverty, with field experience in Africa and Asia.



Jon Temin is Africa Director for Freedom House. He has worked on Africa, governance and conflict issues for more than 15 years. From 2014 to 2017, he was a member of the Departments of State's Policy Planning Staff, providing strategic guidance and long-term thinking to the secretary on Africa issues. Mr. Temin previously served as director of the U.S. Institute of Peace's Africa Program, overseeing the Institute's efforts to help end conflicts and prevent new violence across the continent. Mr. Temin holds a B.A. from Swarthmore College and an M.A. in international relations from

The Johns Hopkins University School of Advanced International Studies. He is a former Fulbright fellow in Ghana, where he worked with the Ghana Center for Democratic Development on monitoring media coverage of the 2000 elections. He is also a term member of the Council on Foreign Relations and a non-resident Senior Associate with the Center for Strategic and International Studies.



E.J. Hogendoorn is the Africa Deputy Program Director for the International Crisis Group. He is based in Washington, DC, and travels often to the region. E.J. frequently briefs the media, international organizations and government representatives on African issues. Previously the Crisis Group's Horn of Africa project director, E.J. was a former Arms Expert with the United Nations Panel of Experts on Somalia (2002-2003) and Sudan (2005-2006). Prior to that, he worked as a researcher for the Human Rights

Watch Arms Division and with Amnesty International USA. He has a Ph.D. in Public Affairs (Security Studies), Woodrow Wilson School of Public and International Affairs, Princeton University.

Alexis Arieff is a Specialist in African Affairs at the Congressional Research Service, where she analyzes policy issues regarding North, West, and Central Africa for Members of Congress and their staff.
