**Dr. Beata Martin-Rozumilowicz** is currently the Regional Director for Europe and Eurasia at the International Foundation for Electoral Systems (IFES). Before starting in February 2016, she headed the Organization for Security and Co-operation in Europe's Office for Democratic Institutions and Human Rights (OSCE/ODHIR) Election Department in Warsaw since 2011 and previously served as its Deputy from 2009 to 2011. From 2005 to 2009, she worked on dozens of ODIHR election observation missions across the OSCE participating states as Deputy Head of Mission or as Political Analyst. In 2005, she served as Election Adviser at the OSCE

Centre in Bishkek, Kyrgyzstan and from 2003 to 2005 was Political/Media Officer at the OSCE Centre in Almaty, Kazakhstan. From 2000 to 2002, Beata acted as Human Dimension Officer at the OSCE's Advisory and Monitoring Group in Minsk, Belarus.



**Dr. Henri J. Barkey** is the Director of the Middle East Program at the Woodrow Wilson International Center for Scholars and the Bernard L. and Bertha F. Cohen Professor at Lehigh University.



Nate Schenkkan is the Project Director for Nations in Transit, Freedom House's annual survey of democratic governance from Central Europe to Eurasia. He previously served as Senior Program Officer for Freedom House's Eurasia programs, covering Turkey and Central Asia. He was the lead researcher and co-author of two Freedom House special reports including *The Struggle for Turkey's Internet* and *Democracy in Crisis: Corruption, Media and Power in Turkey*. He is the creator and host of "The Central Asianist Podcast," a regular interview series with experts and journalists covering the region. Prior to joining Freedom House in 2012, he worked as a journalist in Kazakhstan

and Kyrgyzstan. He has a Master's degree in Russian and Eurasian Studies from Columbia University's Harriman Institute.



**Dr. Ebru Erdem-Akçay** is a political scientist and Turkey analyst. She received her PhD at Stanford University in 2006 and served as an Assistant Professor at University of California Riverside until 2013. She studies identity politics, ethnic conflict, gender equality, and political Islam in Turkey. She is a signatory to the Peace Petition, which called on the Turkish government to stop the ongoing violence in Kurdish dominated southeastern Turkey. She has been involved in the solidarity efforts among the Academics for Peace, most prominently in collecting, organizing, and disseminating the data on administrative and legal retaliation against Academics for Peace.
