"Foreign Assistance. The United States allocated \$336 million in bilateral aid for DRC in FY2021, and also is the top financial contributor to the U.N. peacekeeping operation in DRC (with \$311 million allocated in FY2021) and the top country donor of emergency humanitarian assistance (\$443 million provided in FY2021). Several U.S. aid programs seek to improve adherence to human rights and labor rights in the mining sector. These include:

- U.S. Agency for International Development (USAID) Commercially Viable, Conflict-Free Gold Project. Budgeted at \$12 million, 2018-2023.²
- USAID Sustainable Mine Site Validation Project. Budgeted at \$3.7 million, 2018-2022.³
- State Department support for the Public Private Alliance for Responsible Minerals Trade (PPA). Renewed in 2017 for five years; funding data not publicly released.⁴
- **Department of Labor compliance with international labor standards project.** Grant awarded in 2021 for \$3 million; timeline for implementation not publicly specified.⁵ ..."
