TED DEUTCH AJC Chief Executive Officer



Ted Deutch assumed the role of CEO of American Jewish Committee (AJC) on October 1, 2022. He joined AJC following more than 12 years of service in the United States House of Representatives, representing Broward and Palm Beach Counties in Florida.

In Congress, Ted served as chair of the House Ethics Committee, a senior member of the House Judiciary Committee, and a senior member of the House Foreign Affairs Committee, on which he served as chair of the Middle East, North Africa, and Global Counterterrorism Subcommittee.

As a founding co-chair of the House Bipartisan Task Force for Combating Antisemitism, Ted spoke passionately on the House floor, confronting colleagues who invoked antisemitic tropes or disparaged Israel. In response to rising hatred on social media, he helped launch an interparliamentary coalition to combat online antisemitism with legislators from Canada, Israel, the United Kingdom, and Australia.

As Senior Vice President, International Affairs, Marina G. Rosenberg oversees ADL's work combating antisemitism and hate outside of the United States as well as supporting the Jewish and democratic state of Israel. She leads a team of professionals in the U.S., Europe and Israel pursuing ADL's mission of fighting antisemitism globally, promoting the security of Jewish communities around the world, and advocating for a safe and democratic State of Israel. A former ambassador and diplomat, Marina joined ADL in early 2023 after 16 years of service in Israel's Ministry of Foreign Affairs leading diplomatic missions abroad.
