According to police statements, those who are detained under this law are alleged "to have undertaken acts that undermine independence, sovereignty and self-determination, encouraged foreign interference in internal affairs, requested military interventions, organized with financing from foreign powers to execute acts of terrorism and destabilization, encouraged economic, commercial and financial blockades against the country and its institutions, demanded, celebrated and applauded the imposition of sanctions against the State of Nicaragua and its citizens, and damaged the supreme interests of the nation."
